I am aware that the Operator will process my personal data in the scope established by the Gambling Act, by Act No. 253/2008 Coll., on Certain Measures against Money Laundering and Terrorist Financing (hereinafter referred to as "the AML Act") and by Act No. 69/2006 Coll., on the Implementation of International Sanctions (hereinafter referred to as "the Act on International Sanctions"). Such personal data is processed for the purpose of identification, detection of suspicious transactions, checking lists of persons excluded from participating in gambling and checking persons for the implementation of international sanctions. Personal data is processed in compliance with applicable legislation of the Czech Republic and the European Union, for the period of validity of registration and for a further period of 10 years, which will begin to run on the first day of the calendar year following the year in which the last visit to an establishment is made. (Section 46 of Act No. 186/2016 Coll., in connection with Section 16 of Act No. 253/2008 Coll.). Once this period elapses, the personal data will be erased without further use. I am aware that I have the right to be informed and the right of access to my personal data, the right to correction

and erasure of my personal data, provided that this does not contradict statutory requirements, and the right to object to its processing.

By providing biometric data to the Operator and using technology which makes use of such data for the purposes of identification, access to a user account and participation in games of chance, I grant the Operator my consent to the processing of such data. I am aware that such data will be stored until the date on which I withdraw my consent to its processing.

As the Operator is a part of the NOVOMATIC Group of Companies and, in the Czech Republic, a member of the European Data Project s.r.o. Group, I am further aware that provided personal data can only be communicated to members of these groups and will not be transmitted to any third parties. My personal data will not be provided to anyone outside of the European Union.
